40. MINISTRY OF LOCAL GOVERNMENT

- 40.1 Established under the Local Government Act of 2011, the Ministry of Local Government is responsible for the formulation of policies for Local Government and fire and rescue services. It is also responsible for the construction and maintenance of urban and rural roads, community-based amenities and drainage infrastructure. The Ministry has under its purview the Local Authorities, the Field Services Unit and the Mauritius Fire and Rescue Service.
- 40.2 It envisions, *inter alia*, to provide: efficient and quality local services to improve the wellbeing of the community; and timely weather forecasting and climate services, effective disaster management to build a disaster resilient nation and prompt response to fire and rescue incidents.
- The day-to-day administration of the Ministry is entrusted upon a Senior Chief Executive who is assisted by a Permanent Secretary and supported by officers belonging to other occupational groups. For this Report, Management's proposals were mainly geared towards: a review of salary relativity; the grant of allowance when acting as Secretary of the Unified Local Government Service Board (ULGSB); review of qualifications requirement; merging of levels; and provision of new levels in Local Authorities. Submissions were also made in respect of the Administrative Cadre. The Bureau has examined all the requests and along with their implications.

Secretary, Unified Local Government Service Board

- 40.4 The ULGSB is mandated to look into various human resource matters in Local Authorities, such as redeployment of staff and filling of temporary vacancies. Section 68 (4) of the Local Government Act 2011 provides for a designate position of Secretary, ULGSB. At present, a Deputy Permanent Secretary is assigned its duties against payment of a sessional fee in line with the MPSAR's Circular No. 54 of 2022. In the context of this Report, representations were made for an upward review of the fee payable to incumbent.
- A reassessment of the duties and responsibilities devolving upon the Secretary, ULGSB has shown that this is not a full-time job for an incumbent. Taking into account the nature and level of those duties, we are revisiting the provisions governing the filling of the position, so that henceforth, an officer not below the grade of Assistant Permanent Secretary, now restyled Assistant Secretary, should be designated to act as Secretary, ULGSB.

Inspectorate Cadre

40.6 A request was submitted by Management to merge the grades of Assistant Inspector and Inspector on grounds that their duties are largely similar. However, as the grade of Inspector is, in accordance with its scheme of

service, required to assume supervisory responsibilities, the Bureau cannot accede to this request. Besides, after a comprehensive assessment, broad provisions concerning the Inspectorate Cadre have been made under the heading: Inspectorate Cadre at the Ministry of National Infrastructure of this Volume.
